### PARENTAL AGREEMENT **SKI TRIP 2019 Axamer, Austrian Alps** 16-23 February 2019 Page 1 of 3

- 1. I understand that a booking is being made by The Buckingham School for my child with a tour operator Visions in Education. As a condition of this booking, the initial deposit is non-refundable if my child withdraws from the trip other than on medical grounds. I understand that after the balance has been paid, if my child withdraws for reasons other than on medical grounds, cancellation charges may be payable if The Buckingham School is unable to arrange for the place reserved for my child to be taken by another child.
- 2. I acknowledge that The Buckingham School, notwithstanding my approval by them of this application, shall be entitled to cancel this project at any time, in which case they shall be liable to refund to me any sums paid by me to them but they shall not be liable to refund to me any expenses which I may otherwise incur.
- 3. If my child shall be prevented by illness evidenced by medical certificate, from taking the place reserved by him/her, The Buckingham School shall refund to me any sums recovered by them.
- 4. I hereby agree to reimburse The Buckingham School for all incurred expenses if my son/daughter has to be sent home from the resort for disciplinary reasons. This will include the return air fare of an accompanying member of staff. I understand that any decisions relating to discipline are the sole prerogative of the party leader. I am aware that this is a school organised trip, and that students will not be allowed to smoke or drink alcohol regardless of their age at the time of travel.
- 5. I acknowledge that The Buckingham School:
  - a) May at any time alter the venue, dates, mode of transport or accommodation due to unforeseen circumstances:
  - b) Have absolute discretion to exclude from the journey any student whose conduct and demeanour between the date of this undertaking and the commencement of the journey is unsatisfactory, to such a degree that their presence might have a disruptive effect on general discipline. In this case, The Buckingham School shall only be liable to refund such monies as are recoverable from the tour operator according to the scale of the cancellation charges.
- 6. I agree to pay the £100 non-refundable deposit, by the deadline. I understand this does not guarantee a place and that my son/daughter maybe put onto a reserve list. This deposit must be in by Friday, 23 March 2018 at the latest.

- 7. I undertake to pay the remaining balance as per payment schedule minus the deposit, if my child is allocated a place on the trip. I hereby agree that if I shall fail to pay the above mentioned sums on or before the date due, The Buckingham School shall be entitled at their discretion, to arrange for the place reserved for my child to be taken by another child and shall refund to me any sums paid by me to them. If the place is not so taken I shall remain liable to pay The Buckingham School the sum due in accordance with my undertaking or forfeit my deposit and pay cancellation charges in accordance with the terms as laid down by the tour operator.
- 8. I understand that *Visions in Education* reserves the right to pass on any surcharges due to unfavourable changes in the currency rates, government action or increased fuel costs.
- 9. Students will be responsible for providing their own current passports and European Medical Cards (EHIC).
- 10. I am aware that the school's Senior Leadership Team will be closely monitoring students' Behaviour and Attitude to Learning. The starting point will be their current SDC's at the time of signing and should there be little or no improvement between now and the trip departure date, this could result in removal from the trip. It is vital that all students remain focused and working towards their targets. In the event of Behaviour and/or Attitude to Learning being a concern, a meeting will be arranged with parents/carers, Head of Year and the student.
