Transport policy statement for learners aged 16–18 and continuing learners aged 19 and over

Name of Local Authority: Buckinghamshire County Council **Department Responsible:** Children's Social Care and Learning

1. Summary of Policy Statement and Main Objectives

Buckinghamshire County Council is committed to ensuring that students aged 16–19 have access to educational opportunities at school or college, enabling them to acquire the knowledge, skills and experience necessary for them to pursue their chosen careers and, more importantly, to meet the challenge of employment and personal development in the future.

This Policy Statement describes the assistance with transport costs that is available to students aged 16-19, resident in Buckinghamshire, who are undertaking full-time further education courses.

2. Financial Support Schemes

2.1. The 16-19 Bursary Fund

A key priority of the Government is to close the gap in attainment between those from poorer and more affluent backgrounds, and to ensure every young person participates in and benefits from a place in 16-19 education and training. The Government provides funding to tackle disadvantage both through the Education Funding Agency's (EFA) funding formula and through the £180 million 16-19 Bursary Fund to help young people meet the costs of participating in education and training post-16. The scheme is made up of two elements:

- Bursaries of £1,200 a year are available for the most vulnerable groups. This includes:
 - Young people in Care
 - Care Leavers
 - Young people claiming Income Support or Universal Credit
 - Disabled young people in receipt of both Employment Support Allowance and Disability Living Allowance (or Personal Independence Payment)

The rest of the fund is awarded on a discretionary basis by education institutions. Institutions decide how to use this funding and can award discretionary bursaries to any student that is facing genuine financial barriers to participation. Institutions set their own eligibility criteria, decide on how much is paid, and they set their own conditions for students to meet in order to receive a bursary; for example, linked to behaviour or attendance or assistance with travel costs.

2.2. Care to Learn scheme

Care to Learn (C2L) helps young parents (under 20 years old when their course starts) to continue in or return to learning by assisting with the costs of childcare and associated travel. Any publicly-funded learning in England can be undertaken.

The scheme pays up to £160 per week per child directly to the childcare provider on behalf of the learner (£175 if the learner lives in London). The childcare provider must be registered with Ofsted or the Care Quality Commission, as described in the Care to Learn Provider Guidance.

The costs of travel between the student's home and their childcare provider may also be paid if the combined cost of childcare and the travel does not exceed the maximum weekly amount.

3. Transportation Schemes

3.1. College Transportation:

3.1.1. Aylesbury College

The Aylesbury College Support Scheme can provide students with travel money which will get paid directly into their bank accounts on a weekly basis. Students can apply for travel support if they are aged 16-19, live more than 3 miles away from Aylesbury College and have a household income of less than £25,000. This support is dependent upon 90% attendance by the student.

3.1.2. Amersham and Wycombe College

Assistance with travel costs will only be made for students not qualifying for Buckinghamshire County Council's 16-Plus Free Travel Scheme or any similar scheme offered by the home authority. All support is means tested and the maximum amount paid to assist with travel is normally £150 per term. For enquiries please call 01494 585 387 or email: StudentAdvisors@amersham.ac.uk.

The College also provides a number of bus services. The routes are:

- Marlow to/from High Wycombe Campus (via Bourne End and Wooburn Green)
- Princes Risborough to/from Amersham Campus (via Great Missenden);
- High Wycombe town centre to/ from High Wycombe Campus;
- Hemel Hempstead to Amersham Campus;
- Chesham to High Wycombe Campus (via Amersham, Beaconsfield, Holtspur, Loudwater);
- Shuttle between Amersham station and Amersham Campus.

These services run at the beginning and the end of the day only and are intended for students for whom there is otherwise no suitable public bus or train service. The College also provides minibus transport for certain students who are eligible to receive support.

3.1.3. Berkshire College of Agriculture (BCA)

BCA offer transport from a wide range of areas. The charge of the annual pass for 2017/18 will be from £600 for an annual pass. Students will also be able to purchase single journey tickets from the college reception. Learners aged between 16-18 and 19-24 from low income households may be eligible to apply for financial assistance with regards to the cost of the BCA transport through the Discretionary Learner Support Fund.

3.2. The Buckinghamshire County Council 16-Plus Free Travel Scheme:

Buckinghamshire County Council and its partners are committed to helping students overcome barriers to learning and provide wider access to ensure that people from all backgrounds, irrespective of where they live or their personal circumstances and responsibilities, can take part in learning.

Buckinghamshire County Council runs a 16-Plus Free Travel Scheme. This scheme provides free transport during the 2017/18 academic year for students who have an Education, Health and Care Plan (EHCP) and meet the eligibility criteria below.

Free transport is arranged for those who meet the eligibility criteria in this scheme (as detailed below) who are 16, 17 or 18 years of age before 1st September including those who have commenced their current course prior to their 19th birthday (where transport assistance will be provided until they complete their course). A passport sized photo will be required for a bus pass where transport provision is to be on a bus service and this will be requested by the SEN Transport Officer.

Who can join the 16-plus free travel scheme for academic year 2017/18?

You can join this scheme if you meet <u>all</u> of the following criteria;

- You have an Education, Health and Care Plan (EHCP) and
- You live in Buckinghamshire and
- You were born after 31st August 1998 and before 1st September 2001 and
- You live more than 3 miles walking distance from your chosen school or college and
- You will be undertaking a full-time further education course (or similar course as deemed by the Local Authority) of at least 16 hours per week **and**
- You will be attending your nearest school or college (for travel purposes) that provides the further education course required and
- You are progressing to the next level of further education from the level of course you completed last year (students re-taking or studying GCSEs only will not be entitled to this travel scheme)

The map over page shows the nearest or most appropriate college for the area in which you live. If you meet all of the above criteria and begin your current course prior to your 19th birthday we will provide travel assistance until you complete the current course.

You cannot join the scheme if:

- You do not meet all of the above criteria
- You will be undertaking a higher-education course
- A similar (but not necessarily identical) course is available at a school/college which is nearer and/or more appropriate to travel to

Note: The Council will be looking to consult on its Post-16 Free Travel Scheme during the 2017-18 academic year in preparation for the annual publication of our policy statement at the end of May 2018.

Mileage allowance for entitled students


In limited circumstances, we may agree for you to claim a mileage allowance for travelling by car or motorcycle. If you are entitled to a mileage allowance it will be for one return journey per day. However, we do have the right to offer you public transport or an existing transport service instead if the mileage allowance is not the cheapest option. If we agree to give you a mileage allowance, we will send you a claim form each term and you will need to complete this with sign off from the school / college and return to the Client Transport SEN Transport Team.

What transport will be provided?

Entitled students will receive a travel pass for either a dedicated school bus (6th form / year 12 eligible students) or public transport service. We have the right to limit places to a specific service that is available only at the beginning and end of a normal academic day. We do not issue travel passes for single outward or homeward journeys only.

The following map shows the nearest or most appropriate college for the area in which you live.

How is my travel pass renewed?

Students will be provided with an annual pass which will then be renewed each summer for the following academic year. You will either be sent a renewal form in June/July 2017 from the Admissions & Transport team, and be asked to complete it informing us of any changes to your course / place of study as detailed below, or it will be renewed through the SEN Team based on the following and any changes to circumstances.

We only carry on providing transport each year if you progress onto the next level up in education. This is assessed on a case by case basis taking into consideration individual learning needs and circumstances. This can be progressing onto the second or third year of the course or moving up a level i.e. from a level 1 course to a level 2 course or from a level 2 course to a level 3 course. If you change subjects but remain on the same level as the previous academic year this is not a progression and students will be refused transport for that particular year.

Where a student who has been in 6th form / year 12 / college during the 2015/16 academic year and was entitled to transport under the 16-Plus Free Travel Scheme, during the first year of their course, but do not hold a statement of SEN or an EHCP for the academic year 2017/18, their entitlement will be honoured for the coming 2017/18 year whilst they complete their course, where they continue to meet the above criteria of progressing onto the next level of their course and the other eligibility criteria.

What do I do if my travel pass is lost or stolen?

If your travel pass is lost or stolen, you will need to send a cheque or postal order for £13 (payable to Buckinghamshire County Council) with a written request for a replacement. You must quote your student reference number, name, address and date of birth, and send your cheque and written request to Client and Public Transport. An online payment option is also available to pay for replacement passes.

3.3. Paid-for Travel Scheme for School Sixth Form / year 12 students:

Where there is spare capacity on home to school buses, places may be sold to 6th form learners who do not qualify for the 16-Plus Free Travel Scheme. The Paid-for Travel Scheme fare rate is available on the Paid-for school transport and Post-16 Transport web pages. Bus and Rail services (Prices as at April 2017):

3.3.1. Arriva

Arriva offer daily, weekly monthly and annual zone tickets for their buses; and students are entitled to a student discount. The price for an annual all zones ticket for Herts/Beds & Bucks is £609. Student NUS, ISIC, or College ID card and number will be needed to validate your ticket.

3.3.2. Chiltern Railways

Chiltern Railways offer season tickets for periods of a week, month, month + (a more flexible ticket) or a year. A monthly ticket from London Marylebone to High Wycombe costs £329.90 and a weekly ticket costs £85.90. Holders of monthly or longer Season Ticket or Travelcard Season Ticket valid to High Wycombe station can use their ticket for free travel on local Arriva buses within the High Wycombe urban area at any time of day, 7 days a week. Holders of monthly or longer Season Ticket or Travelcard Season Ticket valid to Aylesbury station you can use this ticket for free travel on local Arriva, Silver Rider, Water Rider and Purple Route 7 buses within the Aylesbury urban area at any time of day, 7 days a week. Holders of monthly or longer Season Ticket or Travelcard Season Ticket valid to Aylesbury Vale Parkway station you can use your ticket for free travel at Monday to Friday peak times on Arriva bus 16 to/from Steeple Claydon, Westcott, Quainton and Waddesdon.

3.3.3. Carousel Buses

Carousel Busses offer daily, weekly and monthly zone tickets. There is a 25% student discount on single and day return fares on most of the commercial routes. Please contact the bus company for information on cost and availability.

3.3.4. First

3.3.5. 16-25 Railcards

16-25 Railcards are available for full-time students between 16–25 years, at a cost of £30.00 a year or £70 for 3 years. This allows holder to receive one-third off most off-peak rail fares (price as at May 2016).

3.3.6. Citizen Card

Buckinghamshire residents aged 16 and 17 are entitled to the 'Make More Citizen Card'. The Citizen Card entitles card holders to travel on buses at a reduced single fare for £1.20 per single trip within Arriva's Aylesbury and Wycombe zone and Carousel Buses' zones 1, 2 and 3. Single journeys operating outside of these zones or crossing the zone borders will be £1.50. The card is only valid for journey after 9am on weekdays and all day at weekends. 4. Times of day that learners can use their travel pass

Buckinghamshire County Council's 16–Plus Travel pass is valid for one return journey per school or college day and may be restricted to specific service/s. If a student needs to begin their journey before 07:30 or they are required to attend tutored classes after 18:30, extensions to the travel card times can be arranged – please contact the Client and Public Transport team via the Contact Us form on the website.

All college services are available for one return trip per college day, on the specified service.

5. Confirmation that support will continue to be made available to learners who reach 19 whilst continuing on a course

Eligible students for transport who have commenced their current course prior to their 19th birthday will continue to be entitled to transport assistance until they complete their course.

6. How will learners be assessed to see if they are eligible for support?

See sections 2 Financial Support Schemes and 3 Transportation Schemes above for details on eligibility assessments.

7. Transport assistance available for students aged 16-18 with learning difficulties and/or disabilities, including those aged over 19 or learners facing other difficulties in following their courses.

7.1. The Buckinghamshire County Council 16-Plus Free Travel Scheme:

Buckinghamshire County Council will provide appropriate transport for students aged 16–19 years with special needs who are entitled through the 16–Plus Free Travel Scheme as detailed above under section 3.2.

7.2. Young adults with a learning difficulty and/ or disability aged 19–25 who do not have an EHCP

A contribution to transport costs may exceptionally be available from Buckinghamshire County Council's Communities, Health and Adult Social Care (CHASC) service area for young adults with a learning difficulty and / or disability aged 19–25 who do not have an Education, Health and Care Plan (EHCP). This will be dependent on the young adult being assessed as eligible under the Care Act 2014 and education forming part of the assessed eligible need. In these circumstances, transport to and from the education provider may be taken into account, but would be subject to the Adults and Family Wellbeing *charging policy* as detailed in the link below:

Young adults aged 19-25 with a learning difficulty and / or disability may also be eligible for a Motability Allowance, depending on the nature of their primary need.

Where possible we will provide information on any other schemes (i.e. community transport education journeys and taxi card scheme / voluntary car schemes) that might be of assistance, according to the individual circumstances of the student.

8. When should learners start to apply for transport support?

8.1. College Schemes

See section 3.1 above for details on support provided directly through the Colleges and section 12 below for college contact details.

Although it is possible to apply at any time for FE college transport schemes, it is advisable to apply early as places are often limited and allocated on a first come first served basis.

8.2. Bucks 16-Plus Free Travel Scheme

Eligibility for the 16-Plus Free Travel Scheme (for students with an EHCP as detailed above under section 3.2) is determined by the SEN Team and you will be informed by them of whether you will receive this.

10. What help is available for learners who attend a further education institution which is beyond daily travelling distance and they need to stay away?

10.1. Bucks 16-Plus Free Travel Scheme

Buckinghamshire County Council transport policy deals with daily travel and does not include residential placements.

For students who attend a further education institution which is beyond daily travelling distance, assistance with travel to college at the beginning and end of each term may be available through Buckinghamshire County Council's 16-Plus Free Travel Scheme.

10.2. Government Schemes

There are two government schemes that offer support with accommodation costs for students:

10.2.1. the Residential Bursary Fund (RBF)

The Residential Bursary Fund (RBF) is intended to provide financial help towards the costs of accommodation for young people attending one of the designated institutions delivering specialist provision, where that provision requires the young person to be resident in order to participate because it is not available locally and/or because it requires students to be available at unsociable hours on a regular basis.

10.2.2. the Residential Support Scheme (RSS).

The Residential Support Scheme (RSS) provides financial support with accommodation costs for students (aged between 16 and 18) who need to live away from home to study because their course is not available locally. Please contact your college for further details.
