Distance Learning

The Easter break has been and gone and we have finished our first week of the summer term. I would like to take this opportunity to remind you all of the expectations around distance learning for your children and hopefully answer some of the questions that have arisen this week. As I have said previously, we are extremely grateful for all feedback we receive as we continue to adapt our practices to best suit the needs of all members of our community.

Years 7 and 8 - KS3 Independent Learning Grids

Most of the questions and queries we have received have been from families who are unsure of the expectations surrounding the KS3 learning grids. I would like to apologise for the fact that these were perhaps not as clear as they could have been.

The idea with the independent grid is that it is designed to be flexible and adaptable to your own environments and to your children. With so many different home environments, we wanted to create something that was accessible and achievable for all, hence why there are no deadlines and no expectations on the amount that needs to be completed. We are looking for you to work with your child to decide on what is an acceptable amount of work, dependent on the environment you are in. Alongside the main independent learning grid that is accessible on our website (https://www.buckinghamschool.org/page/?title=Distance+Learning+Resources&pid=304), we have also asked each curriculum area to create independent tasks for students to select if they wish. These are available on Google Classrooms and, again, there are no expectations around the volume of work or the timeframe in which it needs to be completed. If your child has a particular interest in one subject over another and would like to do some more of the work in that area, we encourage it. The whole system is designed to meet your needs and your child's interests.

Although we are not asking for work to be submitted, we would love to see what you've been up to and are asking you to send pictures of the things you've been doing to our TBS Superstars email address, tbsstars@buckinghamschool.org. It really has been a pleasure seeing all of the wonderfully creative things our students are getting up to!

Years 9 and 10

Having spoken to many Curriculum Leaders this week, they are very happy with the way in which the majority of our Year 9 and 10 students are approaching both the tasks set and the engagement levels on Google Meet. We are asking for one assignment per week to be completed, alongside your child accessing a virtual classroom on Google Meet - the details of which will be shared on the Google Classroom.
